PAKISTAN FOOTBALL FEDERATION ELECTION – 2011

ADMINISTRATIVE INSTRUCTIONS

1- GENERAL

The election to elect new office bearers of District / Provincial and PFF will be held from March to August 2011. These instructions lay down the administrative plan to support Election Commissioners & Districts Convener for holding fair & impartial election. These instructions shall be read in conjunction with Election Rules and Directive - 2011.

2- EXECUTION

The election process shall be executed in three stages mentioned below:-

a. Stage 1

District Football Association's election by 30th March, 2011.

b. Stage 2

Provincial Football Association's election by 30th April, 2011.

c. Stage 3

PFF election by 30th July, 2011.

3- DISTRICT ELECTION

a. ELECTION COMMISSIONERS

- Election Commissioners move to their respective Province on 26th March, 2011.
- Briefing of District Conveners on 27th March, 2011 at 10:00hrs and handing over of appointment letters to Conveners. (Annexure - A)
- Disposal of appeal against rejection of nomination paper, if any on 27th March, 2011.
- Approval of final list of candidates on 28th March, 2011.
- Holding of Election of Provincial Referee Association under the respective Provincial Election Commissioner on 29th March, 2011 from 11:00am to 02:00pm.
- Monitoring of Election of District Football Association on 30th March, 2011.
- Move back on 01st April, 2011.

b. DISTRICT CONVENER

- District Convener move for briefing to Provincial Football Association on 27th March, 2011.
- Convener move to their respective District for Election on 29/30th March, 2011.
- Holding of Election on 30th March, 2011 from 10:00am to 01:00pm.
- Intimation of result to election commissioner and Provincial Football Association by mid night 30th March, 2011.
- Hand over duly signed election "RESULT SHEET" to Election Commissioner by 03rd April, 2011.

4- FINANCIAL IMPACT

PFF will pay TA/DA to each District Convener as per their entitlement.

5- PROVINCIAL FOOTBALL ASSOCIATION ELECTION ON 30TH APRIL, 2011.

- Election Commissioners move to their respective Provincial Association on 29th April, 2011.
- Holding of Election of Provincial Football Association on 30th April, 2011 (10:00am to 02:00pm).
- Move back 01st May, 2011.
- Hand over duly signed "RESULT SHEET" and "ATTENDANCE SHEET" to General Secretary PFF by 02nd May, 2011.


6- PFRA'S ELECTION

- The election shall be held at PFF Secretariat on 09th May, 2011 from 11:00am to 02:00pm
- 2 x elected members from each Province (President & General Secretary).
- 1 x member from Islamabad Football Association.
- 9 x members arrive PFF for participation in PFRA's Election on 09th May, 2011.
- Election on 10th May, 2011.

- Move back 11th May, 2011.
- 7- **PAKISTAN FOOTBALL FEDERATION ELECTION ON 27TH JULY, 2011.**
 - 28 Congress members arrive at Lahore for holding election / meeting on 26th July, 2011.
 - Stay at Lahore for election 27th July, 2011.
 - Move back after the election 28th July, 2011.
- 8- **GENERAL / MISC.**
 - Election Commissioners shall notify the result of each District Football Association's election on the basis of "RESULT SHEET" (Annexure – B) on 17th April 2011.
 - Election Commissioners shall intimate the result of Provincial Referee Association to Provincial Football Association and forward duly signed "RESULT SHEET" (Annexure – C) to General Secretary PFF by 02nd April, 2011.
 - Election Commissioner shall hand over duly signed "RESULT SHEET" (Annexure – D) of Provincial Election to General Secretary by 02nd May, 2011 for notification.
 - Election Commissioners are requested to arrange their traveling from residence to the place of duty and back under their own arrangements or else request may please be forwarded to PFF fifteen days prior to the departure Date for booking.
 - Accommodation shall be arranged through respective Provincial / Islamabad Football Association.
 - Election Commissioners are requested to intimate their arrival programme to concerned Provincial / Islamabad Football Association for arranging reception / transport.
 - Expenditure incurred on traveling and lodging shall be reimbursed to Election Commissioner by PFF.
 - Local transport shall be arranged by respective Football Association.
